# 45/10 International Competition 2011

# 45.1 2<sup>nd</sup> Dubai International Parachuting Championship and Gulf Cup 2011 5-17 Jan

This competition would be open to anyone who wanted to compete however the BPA, as the National Governing Body would have to nominate a team that would be able to win the prize money. The committee recognised that some competitors wanted to take part for the prize money and whilst it would be a difficult decision to make they would not be able to nominate until the committee was aware of who would be attending.

Julia Foxwell expressed Team Satori's wish to attend and asked the Committee if funding would be available. The Committee responded that as it was not an IPC event there would be no funding available.

# 45.2 <u>8th WC & &th European Championships Arts and 17<sup>th</sup> WC & 10<sup>th</sup> European Championships FS. 1-7 August 2011 Saarlouis, Germany</u>
