Item Minute

38/09 Minutes

39/09 Matters arising

39.1 Update of anti-doping code and rules (minute 16.1)

The BPA Anti-Doping policy was in line with the FAI policy and would remain current.

39.2 Trophy Database (minute 5.5.2)

The discipline reps reported that there were still a few missing trophy images to be added to the database. Steve Saunders suggested that the Pat Hammond Trophy be returned to the BPA office at STC to be handed out at the BPA AGM.

#### 39.3 Sport England Funding: Anneke Glasius (minute 37)

The Committee had deferred to Council 23 June to seek guidance from John Horne regarding an application for Sport England funding by Annie Glasuis of Go Freestyle. John Horne had given guidance, and Loughborough University had stated that they had already allocated this years budget. Go Freestyle would be writing to Loughborough University at the early part of next year to meet the next budget allocation.

#### 40/09 Domestic Competitions 2009

#### 40.1 Classics & Canopy Piloting Nationals, 23-25 Jul, RAPA, Germany

Paul Moore reported that the CP event had 18-19 competitors which finished successfully. However 1 competitor had to be red-carded and stood down. Of the proposed 10 rounds in Accuracy only 8 rounds could be completed but the event had seen an increased turnout of competitors. The competitor the Committee had given a permission to compete had behaved in a professional, safe and responsible manner. Due to bad weather, the Style discipline had been unable to take place. Paul Moore had, before the meeting, put forward an informal call to centres that may wish to host the event. Peterlee and South Cerney had expressed an interest and would be submitting a basic price structure in the near future.

Andy Scott stated that each centre would have a 3 weekend window from the 19 September 09 for the event to take place. As entry fees had already been paid to RAPA, in the best interest, the Competitions Committee would ask the dropzone to put on the event so the committee would bear the cost of the judges and of getting the equipment to the event. Also the committee would forgo the entry fee.

It was therefore proposed by Paul Moore that the Competitions Committee would fund Judges and waiver entry fees for those that had paid at the original Style event. This was seconded by Steve Saunders.

The Committee wished to make it clear that the competition was open to all however selection would fall primarily to those that attended the original Classics & Canopy Piloting Nationals. Paul Moore would provide the new hosting centre with a list of Attendees.

The Criteria for the recording/retraining red carded members was discussed. Further input from Alex Wilson would be required.

A letter from Jeff Chandler, which had been received on the morning of the meeting, had been tabled as this raised some competitor issues with the event. Andy Scott felt that as Kate Charters was not at the meeting no comment could be made on the judging issues arising and would forward the letter on for her comments. # 40.2 4-Way & VFS Nationals 8-10 Aug and 4 Way Reserve, 8 Way FS, Artistic, CF and Speed Skydiving Nationals 15-17 Hibaldstow

Martin Soulsby reported that FS Nationals, that were held over 2 weekends; where 47 4-Way teams had taking part, were highly successful. Team Satori set a 20.7 average, a new British record. The Committee wished to extend their congratulations. The 1<sup>st</sup> weekend event was completed in one day. Martin would like to compliment the judges as the 2 panels of 4 judges worked very well. The Competitions Committee understood the rationale of the drop zone on wishing to take advantage of the current weather and completing in one day. The 2<sup>nd</sup> weekend was FS 8-way, Artistics and CF, which was completed in 2 days. 7 FS teams took part consisting of 4 open and 3 intermediate. Weed Stoodley had sent; previous to the meeting, a report of Artistics Nationals. 17 teams consisting of 5 Freefly A, 5 Freestyle A, 4 Freefly B, 1 Freestyle B 1 Skysurf A and 1 Skysurf B with 111 team jumps taking place. Feedback appears to be positive and there were no major issues observed. Martin Soulsby would like to note that having been to a number of World Meets where the Artistics have been frustrating with the speed of judging. It was refreshing to have scores coming out before the next round. Weed agreed, however noted this was assisted by the ongoing and excellent improvements in the Cametrix system for artistic judging plus the fact that a lower number of 'shared' camera flyers were required this year.

Steve Saunders reported that the CF event had been completed and well attended. His report would be ready for the next meeting. Some issues around the running order and judging matters were raised. It was reiterated that you cannot protest a judge's decision; however you could protest the rule. It was felt that the Committee could not comment further on the judging matter and would wait until the next meeting for comment from Kate Charters.
