# 65.1 Results for all disciplines/AGM Awards

The BPA Office confirmed they had all the information required for the Awards Presentation at the forthcoming AGM.

Steve Saunders, having located the whereabouts of the Pat Hammond Shield for 2 Way Canopy Formation Novice Intermediate, asked the Committee if it would be acceptable to represent the Shield to Jamie Flint at the AGM Awards Ceremony. The Committee agreed this would be acceptable and a fitting tribute to Pat Hammond.

### 65.3 British Team Fund Payment Update

Following a confusion regarding entry fees and payment by a dropzone to the British Team Fund Andy Scott was happy to report that this matter had been resolved, and payment had been made.

Noel Purcell, on behalf of Target Skysports, had expressed concerns over the raising costs of Judges expenses, in particular those Judges brought in from overseas. The centre had had to find an extra £1249 to cover airfares for 4 judges, from the USA, Russia, Sweden and Germany. The centre acknowledged the events were run 'at no cost to the BPA' but felt that had they been informed of the overseas judges in good time cheaper alternative flights may have been found. The Committee acknowledged that there was a shortfall of UK Artistic Judges and sympathised with the centre, however there was scope on the bid form for the centre to name judges and to ask questions of costs before the event however the Committee agreed there may have been a breakdown in the organisation of judges for the FS/Artistic Nationals, and that Target Skysports should not be penalised. The host DZ agreed with the Committee that it was not the intent to see the British Team Fund payment impacted. Following discussions Weed Stoodley proposed and was seconded by Martin Soulsby that:

- a. Target Skysports should transfer the remaining payment of £1249 to the British Team Fund as agreed at the time of bidding
- b. the BPA Office will refund Target Skysports £1000 from the Judges budget from the Competitions Committee action plan, to cover extra costs of judging panel over and above the norm

### 66.1.3 Grand Prix - Accuracy

2 bids were tabled, from BKPC and Silver Stars. Discussion followed as to whether previous events were well enough attended to warrant 3 GP Accuracy events in total. Weed Stoodley proposed, seconded by Martin Soulsby, that both the 2 additional bids be accepted. The vote was For - 3, Against - 0, Abstentions - 1 (Steve Saunders)

# 66.1.4 **Grand Prix - Canopy Formation**

3 bids, from BKPC, BPS Langar and Silver Stars were tabled. The bids were considered, with a view to previous attendance records.

It was therefore proposed by Steve Saunders and seconded by Paul Moore to accept the bid from BPS Langar.

### 66.2 Nomination of Judges per event/ Chief Judges

The Committee discussed the need of hosting centres to have knowledge of the Judges in place for their events well in advance to take into consideration costs involved. It was noted that historically most centres had entered on their bid forms, for Proposed Chief Judge and Judges "To be confirmed". Moving forward as all events dates were known well in advance there was a possibility to allocate judges now. Paul Moore proposed and was seconded by Steve Saunders that the Andy Scott should write to Kate Charters, Judges' Co-ordinator, to list Chief Judges and volunteers for each event, and to identify any shortfalls. The list was to be received by the BPA Office by 22 December 09.

## 66.3 Purchase of Parachuting Equipment

Paul Moore had compared costings from Weckbecker and Texair Limited. Whilst some of the Committee had heard use of the Weckbecker system it was believed that further experience of the Texair system would be required before a decision could be made. Andy Scott would approach Headcorn to ask to trial the system at their GP Accuracy event on the 1-2 May 2010.

# 67/09 5<sup>th</sup> FAI World Cup in Canopy Piloting 09, Johannesburg S Africa 1-6 Dec 09 67.1 Head of Delegation Report/Results

Paul Moore reported the event had been well organized, with 13 Nations represented by 65 competitors, 10 of which were from the UK. The conditions, both the course and the weather, had been very challenging and there had been a number of injuries, and one fatality. The UK delegation all jumped safely, only sustaining cuts and bruises.

Brian Vacher had been the highest placing UK competitor in 6<sup>th</sup> position, Alastair Macartney in 16<sup>th</sup>, Deane Smith 19<sup>th</sup>, Martin Reynolds 20<sup>th</sup>, Wez Westley 24<sup>th</sup>, Spencer Hogg 27<sup>th</sup>, Simon Larcombe 29<sup>th</sup>, Sean Sutcliffe 34<sup>th</sup>, Kieron Hayes 40<sup>th</sup>, Stuart Storey 49<sup>th</sup>. Kieron had done very well as this was his first Class 1 event.

Both the Speed and the Distance British Records had been broken. Brian Vacher had set a new British Distance Record of 167.73m. Wez Westley set the British Speed Record of 2.424 sec, only for Alastair Macartney to break it 2 days later with 2.404 secs, then again by Martin Reynolds with 2.360 sec, only for Wez to take the record back 28 minutes later with 2.347 sec. All of which made for good watching.

The amount of injuries at the event highlighted the need for correct skydiving insurance that covered competitions also. The Committee recognised that the BPA had a duty of care to the UK delegation. Whilst the BPA Office held copies of current insurance documents that had been submitted by competitors before taking part in a competition there was a need to identify to the competitor that the insurance they had in place may not cover competition jumps, and that their insurance must cover repatriation. Andy Scott would approach Manson Insurance Brokers, via the Insurance Sub-Committee Reps, for advice on the potential to cover invalid cover or any shortfall in cover by a delegation member, and to ask what they may have available as a policy.

### 67.2 Funding Matters

The Committee discussed the possibility of funding Deane Smith and other Canopy Piloting competitors, from the 10k setaside, for the World Parachuting Championships in 2010. Deane Smith's training plan had been tabled at the previous meeting. The following points were raised:

- The funding of CP was potentially not as much as it could be
- Whether the published funding criteria was correct
- Whether the Competitors had met the published funding criteria
- The potential to win medals
- The potential for some/all of the available funds to be used for coaching of the delegation as a whole as the competitors had recently discussed in a meeting at the World Cup 2009 venue
- The potential for some/all of the available funds to be used for the coaching of upand-coming Canopy Piloters

Weed Stoodley proposed that as she felt that no CP competitors had met the published funding criteria, the setaside 10k balance be divided between the 15 competitors that did qualify, not including Satori. This failed to find a seconder.

Martin Soulsby proposed, seconded by Weed Stoodley, that due to the confusing funding criteria, that £2900 be put towards a Coach for the 2010 CP delegation at a venue of their choice, as a one-off case.

Carried

Deane Smith's training plan was reviewed, and Paul Moore proposed that Deane Smith should be funded £7000, as requested on the training plan, for the World Parachuting Championships and beyond. This failed to find a seconder.

Paul Moore then proposed funding of £5000, with the £2900 excluded, for Deane Smith. This was seconded by Steve Saunders. The vote was For - 2, Against - 2. The Chairs vote was For.

# Carried, subject to ratification at Council this evening

[Note: At Council that evening the matter was discussed further and another vote resulted in a change to the funding of Deane Smith down from £5000 to £2900 in line with per head funds of other 2010 funded delegation members - Council minute 95.3.2 refers]

#### 67.3 Canopy Piloting Technical Rep

As Alex Wilson was not available to stand for Council in 2010 Paul Moore recognised there was a potential lack of CP knowledge within the Competitions Committee. The Committee also acknowledged there needed to be greater technical input to the funding criteria for CP which stands alone in different location influences. Paul Moore therefore proposed that Martin Reynolds, as a CP competitor, be co-opted to Competitions Committee as CP Technical Rep to advise on CP competitions. This was seconded by Steve Saunders. Martin Reynolds was happy to take on this role.

# Carried Unanimously, Recommend to Competitions Committee 2010

Paul Moore, as he has an interest in the discipline, expressed his wish to volunteer for the role of CP Discipline Rep. This would be discussed at the BPA Inaugural Meeting at the BPA AGM 2010.

The BPA would ask FAI if they had received a copy of the Judges List as Kate Charters was required to forward the FAI Judges list to the FAI by 31 December 2009.
