### Item Minute

#### 23/04 Minutes

#### 25/04 Reports on areas of responsibility

##### 25.1 Insurance

Tony Butler reported that a regular liaison meeting with the underwriters and brokers had recently been held at the BPA Office, at which various issues had been discussed. There was nothing specific to call to the Committee's attention.

##### 25.2 Media liaison

Elizabeth Stoodley had circulated a written report in her absence. The Committee noted this with thanks. The Committee approved draft posters to be sent to Drop Zones to invite them to send in news items with photographs for Elizabeth Stoodley to issue to the media.

**26/04 Action Plan, 2004/5**

**26.1 Target 1: Start a new page on the BPA website on National Skydiving Records**

Calvin Blacker, whose idea this was, was progressing it and said he would contact Kate Charters, Chief Judge, to see if she could identify some current UK skydiving records, including the Brit 100, with which to start.

**26.2 Target 2: Host an open forum meeting for Drop Zone Operators**

This was a winter activity, for a one-day meeting probably in November 2004 or February 2005.

**26.3 Target 3: Create a new role as Media Co-ordinator**

Elizabeth Stoodley was active in this new role.

**26.4 Target 4: Improve the quality and quantity of media coverage of skydiving in the UK**

Elizabeth Stoodley had achieved coverage of good news stories about BPA Members' skydiving achievements in a number of local newspapers. She had also received offers of help in media activities from a number of Members who worked in the field.

**27/04 Request for a link on the BPA website**

John Taylor, who had described himself as 'an old parachutist from the past', had suggested that a link to the website of the former Hereford Parachute Club, Shobdon - www.hpc.freehosting.net - should be posted on the links page of the BPA website. Martin Shuttleworth confirmed that this could be done in-house at no cost. Eddie Jones therefore proposed, and Kieran Brady seconded, a motion that the link should be posted on the BPA website.

**28/04 DZ map on BPA website**

Calvin Blacker reported that, on his recent Club Reps' visit to Hibaldstow, a member had mentioned that some of the dots on the DZ map on the BPA website were not in the correct position. He had mentioned this to Martin Shuttleworth who had contacted the website company Centrepages to ask for the position of the dots to be reviewed in line with those on a large map on display at the BPA Office. As it was a dynamic webpage, it could not be altered by the BPA Office.

**29/04 e-mail alerts list**

Calvin Blacker reported that another question he had been asked was about an e-mail alert list, for example to give news of any change in competition dates, etc. Martin Shuttleworth said that such a facility already existed and the sign-up box was on the diary of events page on the BPA website. Sue Waterfield at the office e-mailed monthly events updates.

**30/04 Competitions results archive**

Calvin Blacker reported on a suggestion from his Club reps' visit to Hibaldstow. This was the idea of an historical results archive for FS competitions results and draws. The Chairman said this could be a big project. Martin Shuttleworth said that when information on competition draws was received from the judges, it was posted on the BPA website along with the results. In time, an archive could be built up by leaving previous years' pages online. The Chairman suggested that Calvin Blacker should refer the idea to the Competitions Committee for consideration possibly as one of that Committee's questions for inclusion in the membership survey questionnaire.

**31/04 Meeting start time**
